NOTIFICATION

S.O.1674(E).- WHEREAS M/s. KPR Developers Limited, has proposed under section 3 of the Special Economic Zones Act, 2005 (28 of 2005), (hereinafter referred to as the said Act), to set up a sector specific Special Economic Zone for Information Technology/Information Technology Enabled Services and Electronic Hardware sector at Kollupalayam Village, Arasur Panchayat, Coimbatore District in the State of Tamil Nadu;

AND WHEREAS, the Central Government is satisfied that requirements under sub-section (8) of section 3 of the said Act, and other related requirements are fulfilled and it has granted letter of approval under sub-section (10) of section 3 of the said Act for development operation and maintenance of the sector specific Special Economic Zone for Information Technology/Information Technology Enabled Services and Electronic Hardware sector at Coimbatore District, Tamil Nadu on 27th February, 2009;

Now, THEREFORE, in exercise of the powers conferred by sub-section (1) of Section 4, sub-section (1) of section 13, sub-section (2) of section 53 and sub-section 1 of section 11 of the Special Economic Zones Act, 2005 and in pursuance of rule 8 of the Special Economic Zones Rules, 2006 :

(i) the Central Government hereby notifies the following area at Kollupalayam Village, Arasur Panchayat, Coimbatore District in the State of Tamil Nadu, comprising of the Survey numbers and the area given below in the table, as a Special Economic Zone, namely:-
