NOTIFICATION

S. O. 389(E) . - Whereas M/s. Frontier Lifeline Private Limited, a fully Private Organization in the State of Tamil Nadu, has proposed under section 3 of the Special Economic Zones Act, 2005 (28 of 2005), (hereinafter referred to as the said Act), to set up a sector specific Special Economic Zone for Biotechnology sector within the village limits of Edur of Gummudipundi Taluk in the District of Thirruvallur in the State of Tamil Nadu;

And, whereas, the Central Government is satisfied that requirements under sub-section (8) of section 3 of the said Act, and other related requirements are fulfilled and it has granted letter of approval under sub-section (10) of section 3 of the said Act for development, operation and maintenance of the sector specific Special Economic Zone for Biotechnology sector within the village limits of Edur of Gummudipundi Taluk in the District of Thirruvallur in the State of Tamil Nadu on the 28th day of November, 2008;

Now, therefore, in exercise of the powers conferred by sub-section (1) of section 4 of the Special Economic Zones Act, 2005 and in pursuance of rule 8 of the Special Economic Zones Rules, 2006, the Central Government hereby notifies the following area within the village limits of Edur of Gummudipundi Taluk in the District of Thirruvallur in the State of Tamil Nadu, comprising of the survey numbers and the respective area in hectares given in the table below, as a Special Economic Zone, namely: -
